

ORDINANCE NO. 2023-11

AN ORDINANCE OF THE CITY OF TAYLOR, TEXAS REPEALING ORDINANCE NOS. 2000-10 AND 2021-14 ARTICLE IV, DIVISION 6 OF THE TAYLOR CODE OF ORDINANCES ESTABLISHING THE AIRPORT BOARD FOR THE CITY OF TAYLOR, TEXAS TO BE REPLACED BY AIRPORT COMMITTEE UNDER CITY OF TAYLOR AIRPORT RULES AND REGULATION ORDINANCE.

WHEREAS, the City of Taylor, Texas, adopted Ordinance No. 2000-10, establishing an Airport Board; and

WHEREAS, the City of Taylor, Texas, adopted Ordinance No. 2009-18, amending Ordinance No. 2000-10 to increase the number of airport board members from five to seven; and

WHEREAS, the City of Taylor, Texas, adopted ordinance No. 2021-14, amending Ordinance No. 2021-14 decrease the number of airport board members from seven to five; and

WHEREAS, the ordinances are currently codified under Article IV, Division 6 of the City of Taylor Code of Ordinances; and

WHEREAS, the City Council finds it is in best interest of the City of Taylor to disband the Airport Board in lieu of an Airport Committee to be created under and governed by the Airport Rules and Regulations Ordinance; and

WHEREAS, the City now desires to repeal Ordinance Nos. 2000-10 and 2021-14 creating the Airport Board and replace the Airport Board with an Airport Committee to be created under the Airport Rules and Regulations.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TAYLOR, TEXAS, AS FOLLOWS:

SECTION 1. Ordinances No. 2000-10 and No. 2021-14 and Article IV. Division 6-Airport Board of the Taylor Code of Ordinances are hereby repealed in their entirety and the Airport Board is immediately disbanded to be replaced by the Airport Committee established under the Airport Rules and Regulations Ordinance.

SECTION 2. All provisions of any Ordinance of the City of Taylor, Texas, in conflict with the provisions of this Ordinance shall be, and the same are hereby repealed, and all other provisions not in conflict with the provisions of this Ordinance shall remain in full force and effect.
